#### **RESOLUTION NO. 21-03**

A RESOLUTION OF THE VALLEY SPRINGS PUBLIC UTILITY DISTRICT BOARD OF DIRECTORS TO CHANGE THE BASE RATE CHARGE FOR SEWER SERVICES EFFECTIVE October 1, 2021

WHEREAS, the Valley Springs Public Utility District (District) provides sanitary sewer collection and treatment services for District residents and property owners; and

WHEREAS, Current sewer charges will be insufficient to cover the anticipated cost of the necessary improvements to the Valley Springs Public Utility District sewer collection system and wastewater treatment facility; and

WHEREAS, a notice of the Public Hearing to consider proposed increases to the Sewer Rates was mailed at least 45 days prior to the scheduled Public Hearing as required by state law (Cal. Const. art. XIIID, §6) and;

WHEREAS, on September 22, 2021, the Board conducted a Public Hearing, considered testimony, and at the conclusion of the protest hearing determined that the number of valid written protests received was less than 50% of the total number of water and wastewater customers or property owners subject to sewer rates the City and approved the recommendations in the 2021 Water and Sewer Rate Study regarding adjustments to the Sewer Rates; and

**NOW THEREFORE, BE IT HEREBY RESOLVED,** by the Board of the Valley Springs Public Utility District that the Board hereby approves the Base Rate Charge, as set forth in "Exhibit A" attached hereto and by this reference incorporated herein, to become effective October 1, 2021.

# Monthly District Sewer Service Charges

The monthly fixed base rate will apply per residential unit, including mobile home spaces occupied, and per commercial connection. Each commercial connection will pay the sewer volumetric rate for water use exceeding 6,000 gallons.
